| 7. | <b>COUNTY COUNCIL AFFAIRS:</b><br>Cllr Topping attended the meeting and gave the following report:<br><br><b>"Broadband</b><br><i>I spent a morning with Connecting Cambridgeshire in my role as a Broadband Champion. Fowlmere will not have access to the new speeds for a few more months but it will be in by Christmas. If you see activity at the junction box in the High Street then you will know it is happening. I will update the Parish Council on specifics as the time for Fowlmere to go live gets nearer, but in the meantime:<br/>Connecting Cambridgeshire has been successful in its bid for £1.2 million from the European</i>   |   |

*Regional Development Fund Regional Competitiveness Grant to deliver support for local businesses. This means a countywide support programme for small businesses will be delivered to assist with the adoption of broadband and broadband-enabled technologies. If a household is served by the "live" junction boxes then the next step for people who want faster broadband than they currently have is to test the broadband speed - the Connecting Cambridgeshire webpage tells you how to do this - and then shop around for an improvement by buying what is known as a fibre based package from an ISP provider. Moneysupermarket.com has a good introduction. In some cases - if someone bought a deal from a provider some years ago - it may be cheaper, or it may be a few pounds more a month.*

### **Transport strategy**

*Transport Strategy for Cambridge and South Cambridgeshire - Consultation is currently underway on the draft Transport Strategy for Cambridge and South Cambridgeshire. This is being run alongside the consultations on Cambridge City Council and South Cambridgeshire District Council's draft Local Plans. The consultation period closes on the 30 September. The intention is for the Strategy to be adopted in early 2014 to support the submission of the draft Local Plans to the Planning Inspectorate.*

*Transport issues locally: 31 bus route and highways improvement bid*

*I met with Mike Cooper in late July. His role is now about keeping what is already there going, ie repairs etc, while for new initiatives, Stuart Rushby is more the contact. Mike has carried out further work on drains in Long Lane up the hill to the centre of Fowlmere and is awaiting heavy rain to see if that solves the problem of the outstanding drainage issue in the vicinity of Hope Cottage.*

*He has forwarded the problem with the sign in Piper Close to the signals team, and has removed the sign pointing down at the Foxton crossroads and ordered a replacement. The panel to decide the bids from parishes meets in October. In terms of any bid going in from Fowlmere, I am ready to offer advice and support on the day itself if the parish would find that helpful.*

*31 bus route - I will be able to give an answer tomorrow re bus costs using the 31 and other buses in town. The proposal to route some services via Shelford rail station so enabling people to get trains down to London seems sensible and is worth considering. Replies to the consultation are due in now.*

### **District plan and housing**

*The lack of a five year land supply continues to cause problems for district councils across the country, and in South Cambs this is also the case, as per the recent application at Waterbeach and also at Melbourne where the developers are confident they can win on appeal even though the district planning committee rejected. It follows that the parish council needs to keep close to any possible developments for putting forward land as even though the land may be not part of the district council's plan, the bid could still succeed. Deborah as your district councillor may have more details.*

### **Thriplow recycling depot.**

*The County Council is running a consultation on the future of its Household Recycling Service and this survey finishes on 26 Sept. So if you use Thriplow Recycling Centre - and even if you don't - then it is important to give your views. The County is looking at various efficiency and money-saving options including closing sites, reducing their hours or possibly their days, getting a charity or a not-for-profit to help run, charging for certain types of waste from DIY activity.*

*The decision on the future of the service will be made in the autumn. This is a very useful service and the Thriplow site is always busy. So please let the county know what you think.*

The Electricity Board has been in touch about removing a minimal amount of foliage from the trees in the cemetery - 2 trees only, which are currently touching the electricity wires. Cllr Roberts signed the paperwork.

A) Two memorial Stones for Fowlmere Cemetery

The Cllrs looked at an application for a memorial stone from the Smith family. The first application is too large especially given the proximity to the WW1 War Grave. The Clerk to contact the stonemason to ask it to be reduced by a foot in terms of height and width. Existing approved colours are black, cream, white and a granite brown, and they don't wish to increase the range of colours. The present design is inappropriate and will not blend in with other graves and we have to be sensitive to other graves and other families - the height in particular is too great. The top needs to be levelled or a gently rounded top. They don't want coloured pictures on the stones either - the golfer could be a non-coloured silhouette. Advise they take a look at the rest of the recent stones in the cemetery, to see how it can be best matched in.

Clerk to call 3 other cemeteries to ask rates for residents and non-residents at 3 locations.

The price for 'over 3 foot' to be removed and introduce a maximum width (33 by 33 inches).

The Loveridge grave has been agreed - Clerk to contact to say agreed.

Following a couple of complaints, the Clerk to contact the Webb family about removing some granite stones placed at the foot of the grave, which will get in the way of the mowing.

|     | <p>Nothing was reported.</p> <p style="text-align: center;">*****</p> <p><b>B) UPDATE ON WELDING ALLOYS</b><br/>Nothing further has been reported to any member of the PC.</p> <p><b>C) THE TRIANGLE</b><br/>Cllr Wragg and Cllr Roberts attended a meeting at SCDC in August to see the Head of Legal (S Reed) and two SCDC Housing Officers to discuss the allocation of rented houses in The Triangle. Thanks to their preparatory work, they demonstrated that an Exception Site is completely different from any other affordable housing site. The allocation process appeared not to have complied with the regulations. Significant issues were raised e.g. there was no mechanism in place to audit whether a Registered Social Landlord had verified someone's claims as to where they lived or had close connections. The definition of 'Local connections' had been too vague and there was no 'points' system to enable staff to process this aspect objectively. SCDC had now to challenge the Housing Association to make sure this information met the appropriate criteria. It was to be discussed at CEO level at SCDC, and FPC should hear back from them by the end of September. Certain Fowlmere residents whom we intended to help still have not been allocated these properties. Letter to go up on the noticeboard and further information to the village following the second meeting when there is a way forward to report. Cllr Bearpark thanked Cllr Wragg and Cllr Roberts for all their hard work on this.</p> <p><b>The Meeting was then opened to members of the public.</b></p> <p>Mr Hall mentioned his particular problem with obtaining a rented property on the Triangle, which corroborates the issues discussed earlier.</p> <p>Mr Hall was attending the meeting to ask about holding 'boot camp' sessions on the Green alongside Savile Way and also on The Butts, at variable times, to raise charitable donations. Any damage would be repaired and would not clash with the school using The Butts. It would be based on a maximum of 16 people, to run indefinitely. He would need a CRB check and insurance, so if anything goes wrong the Parish would not be liable, and he and the participants would need to sign a no-liability waiver. The Cllrs advised it would be worth him looking into Public Liability Insurance. The Butts would be better as there is a covenant on the St Mary's land to say no play equipment etc, which makes it unsuitable. The PC agreed it is a good idea and agreed that he should try it out for six months. The PC will formally write to him, to ask him to sign the letter too (3 Savile Way). PC to check they see the relevant insurances and DBS certificate. <b>[ACTION CLERK]</b></p> <p>Mr Pymer also commented on The Triangle to say the Housing Association's behaviour was unacceptable. He considered that the allocations were possibly in breach of the planning policies due to the wrong criteria used, and could be subject to a judicial review, given the funds available.
