6.	<p><b>COUNTY COUNCIL AFFAIRS:</b> Cllr Topping attended the meeting and gave the following report:</p> <p><b><i>“Tackling congestion in Cambridge City</i></b> <i>I attended the Greater Cambridge City Deal Assembly which voted through a set of proposals which - subject to the CD Board agreeing them - will be consulted on over the summer. The proposals are not a flat congestion charge - which some people want - but a package of closing certain roads at certain times of the day to reduce the amount of short car journeys in the City, a workplace parking levy for firms and businesses over a certain size, and efforts to improve public transport, including dropping the charges for the park and ride car parks, and more funding for South Cambridgeshire village buses. The proposals are quite controversial, especially workplace charging. I want to try to move some of the attention of the City Deal out from its current focus on Cambridge City to bus services for local villages.</i></p> <p><b><i>Devolution</i></b> <i>This is about devolving powers from central govt down to Cambridgeshire and Peterborough. One of the possibilities is a sizeable £100m amount of money to be spent on affordable housing mainly in South Cambs and an infrastructure pot. One of the requirements is that there would be a mayor. All the local authorities will be deciding at the end of this month whether or not to start a consultation on this, lasting through to the autumn.</i></p> <p><b><i>Closer to home...roads, paths and traffic</i></b></p> <p><b><i>Land near the school</i></b> <i>Following on from the site meeting with the county surveyor, I agreed the letter that he is now writing</i></p>	

<p><i>to residents giving them notice that the land will be cleared during July. I believe Cllr. Roberts has spoken to Rob Mungovan at the district to get his views on what the site could benefit from to make it a community open space. I suggest that the next step will be to involve the school and I have written to the head.</i></p>	
<p><b>Highways Open Day</b>  <i>This is at the Highways Depot in Whittlesford on Monday 27 June from 10.00 to 5.00 and I urge the parish council to send a team to meet highways officers to discuss issues. The advantage is that all the right people are there in one building so if a proposal needed a view say from the policy people as well as the engineers you can get them into one huddle. This is the time to float ideas for the Minor Highways bids which this year need to be in during the summer rather than late autumn. I have raised with Peter Taylor at highways the issues re the speed signs, but the Open Day would be a good chance to go along with a list of things that need doing.</i></p>	
<p><b>Street Lighting.</b>  <i>The county's contractors are replacing the lights along the A505. This seems to be on schedule. - and I would recommend this to the parish council.</i></p>	
<p><b>Cereals</b> - <i>Although the A505 was severely congested on the first morning, the traffic arrangements for Cereals 2016 seem to have benefited from better planning than 2 years ago. I had a detailed briefing from the organisers some months back and made the point that they had to do better than 2014"</i></p>	
<p>Cllr Topping was asked to express concern over the over-grown A10 verges at Shepreth – the lack of visibility is very dangerous and needs immediate attention.</p>	Cllr Topping
<p>Cllr Wragg asked what % of parking spaces at P&amp;R sites are currently unused? Cllr Topping replied that there has been a drop of 30% because of the new fee to park there. Cllr Roberts has said that Stagecoach will threaten to increase their fees in response. Cllr Wragg - you cannot enter the P&amp;R with a bike on the roof of a car.</p>	
<p>Cllr Topping will attend the Highway's Open Day – please can we send him a list of problems etc and also plans / wishes for the future.</p>	
<p>Long Lane was resurfaced a week ago and some residents had a warning notice but with no date, and other residents didn't receive any warning. The traffic was also dangerous backing up on the A10 when it couldn't turn into the closed road. Cllr Topping to pass this on.</p>	Cllr Topping
<p><b>A) SPEEDWATCH / TRAFFIC / SPEEDING LEGISLATION</b>  Clerk to send the traffic summary to Cllr Topping. The speeding situation is much worse than previously anticipated.</p>	Clerk
<p>Cllr Sunderland to Cllr Topping - what is the rationale of traffic lights eg M11 / Trumpington roundabout, when it isn't rush-hour? Does CCC have a stance? That junction is being looked at, but Cllr Topping will ask Highways at CCC to see if they can be peak time only. This would apply to the whole run into Cambridge through Trumpington, including the new development at Hauxton. You see the red light first on the left hand band at Hauxton and this needs to have an arrow, to avoid initial confusion for drivers going into Cambridge – make the whole section 40mph?</p>	Cllr Topping
<p>Re the draft Speedwatch letter from Cllr Howe. All Cllr's agreed for this to be adopted. Clerk to put the summary on the reverse of the printed document and ask for responses by the end of July. ### **MINUTES OF A MEETING OF FOWLMERE PARISH COUNCIL PLANNING COMMITTEE HELD IN THE SCHOOL ROOM, URC, CHAPEL LANE, FOWLMERE ON MONDAY 13<sup>TH</sup> JUNE 2016 AT 7:30PM**

Cllr Roberts declared that if an application is later placed before South Cambridgeshire District Council she will approach any new information afresh. Also, because Cllr Roberts is a District Cllr at SCDC, the same applies and she will look at any application, which goes to SCDC, afresh.

Outline application for residential development of up to 45 dwellings and office building

**Welding Alloys Ltd, The Way, Fowlmere, SG8 7QS**

Cllr Roberts announced that there would be a short period of time for residents to speak, and reminded those present that members of the public could also send their representation into SCDC. Cllr Roberts then explained the definition of 'outline' planning permission and gave a summary of the site: The site is outside the Village Envelope, Fowlmere is designated as a 'Group Village' (which means that up to 8 dwellings can be built within the envelope, 15 within exceptional circumstances). The site was put in in the SCDC 'search for sites' but it was not chosen. It is designated as an employment site. Fowlmere has a lack of amenities / sustainability which is what has led to the classification as a Group Village. Fowlmere PC support SCDC view of development in line with both the previous and the emerging Local Plan.

The number of dwellings in a following detailed planning permission could not go over the number agreed at the outline planning permission stage. SCDC would try to get 40% as affordable housing (about 80% of normal housing value, not at all similar to the houses at The Triangle, which is a Rural Exception Site).

Part of the site is in the flood zone, there are issues with water supply, foul water drainage, traffic, implications for the village school. Cllr Roberts and Cllr Wragg to check out the intent regarding Social Housing. The feedback from the exhibition put on at Welding Alloys by Carter Jonas only yielded 13 written responses (from the 96 attendees who were not employees) and many asked about a shop but this has not been included in these plans.

Cllr Roberts noted that the best outcome would be to retain it as a local employment site and it is a disappointment that this may not happen.

Pubs have special regulations that mean they need to be marketed as a 'pub' for a year, but this does not apply to this site.

There are issues with the number of parking spaces provided and the predicted low number of potential school children is questionable.

Dr Harris said that on the evening of the initial event they were told the level of affordable housing would be 40%. She has an issue with the number of houses and a single access road with unpredictable, constant and unsafe traffic. Is it possible to challenge the number of dwellings and suggest a lower number? Cllr Roberts said the way to do that is to refuse it and then it may be resubmitted at a lower level but there is a time limitation of the Local Plan being finalised.

Mrs Flynn said the village needs some employment sites.

Mrs Collins - The Post Office needed to be advertised for a year too. Also there is a plot nearby which could have a sizable impact if that is developed in time which could have a huge effect on the nature of the village. Foxton Sewerage system needed to be improved before any further development happened and Mrs Collins wondered if this has happened?

Cllr Bearpark - The Triangle changed the goal-posts after agreement and so he has doubts over this application

(whilst appreciating it is outline at this stage).

WA apparently might be interested in the office block but this may not be the case in the long term.

The Parish Council recommend refusal based on planning policy, to be detailed outside of the meeting - Cllr Roberts, Cllr Wragg, Cllr Bearpark to write the detail and then circulate to all. 6 in support of a refusal.

SCDC to be asked for this to go to Planning Committee if they are not in agreement.

Clerk to ask David Thompson (SCDC Planning Officer) if this can be extended as the submission is to be very detailed. It was understood from Cllr Roberts that the planning officers are not near a conclusion yet.

The Clerk read out a letter from Uzma Ali at SCDC regarding an approach from Nick Green of Saunders Boston, Chartered Architects regarding a potential Exception Site in Long Lane. Cllr Roberts would like someone from SCDC Housing and Planning present, as the PC would only *normally* only discuss an application once a planning application is present. Clerk to reply to Uzma Ali and say that the PC is not against a meeting but it would need to have an attendee from SCDC Planning and from SCDC Housing present for the entire meeting, and to offer Thurs 7<sup>th</sup> or Mon 11<sup>th</sup> July, 7:00 / 7:30 in Fowlmere.

The building work at Ion Science has made this even worse. Sat-navs do not correctly direct people. The postcode of the school is 7SL and Butts Close is 7SY but the Industrial estate goes back to 7SL – could this cause the issue? Cllr Topping – Hinxton had a similar problem with Hexel and they changed a postcode. A meeting with Ion Science could be a starting point, but it is also the existing businesses there. Highways – could a sign be added? Ion Science have not had any signage for their lorries – this would help enormously.
